### **Minute no. 149 – Councillor Payments**

There was a general discussion regarding the need for any Councillor payments to be made through the payroll system. Members were requested to complete the proforma as issued by the RFO to confirm whether they wish to receive the standard payment to cover the annual expenses.

### **Minute no. 150 – Audit Report**

The RFO gave a report on the report of the external auditor. The following matters had been raised and were noted by the Council.

- The Notice of Appointment of Date for the Exercise of Elector's Rights commenced before the Council approved the Accounting Statements and Annual Governance statement on the 18<sup>th</sup> July 2018
- The Annual Return Accounting Statement was approved late on the 18<sup>th</sup> July 2018 however sections of the Annual Governance Statement were blank and had to be returned to the Council for re-approval.
- The Council were unable to provide a copy of the minutes of the meeting at which the 2015-16 audited accounts and audit report were presented.
- A formal schedule of assets should be maintained and regularly updated and should be reported in box 12 on the Accounting Statement on the Annual Return.

**Resolved that** the auditor's report and a copy of the asset register be referred to the next Finance Committee.

### **Minute no. 151 – Bank Mandate**

A report was provided by the RFO on the progress with amending the bank mandate document. It was noted with concern that there is a significant delay by the bank in processing this request which is affecting the ability of the RFO to function efficiently.

### **Minute no. 152 – Card Machine**

The RFO provided a report on progress made with the application for a card machine. There has been a need for a change in the name on the application to Tumble Hall as the operator's system does not recognise a Community Council.

### **Minute no. 153 – Cheque System**

The RFO provided an overview of the amended system for the production of a cheque which involves pre-printed cheques for production by the Council.

### **Minute no. 154 – Debtors**

The RFO provided a report on current debtors. It was agreed that the RFO will arrange to follow up with further invoices as appropriate with the debtors.

### **Minute no. 158 – CDO Report**

The CDO provided an overview to her previously circulated report on community development matters. Members of the council offered the following observations:

#### Community Project

It was agreed that the Council approve in principle this project and authorised the CDO to make further enquiries with local groups to establish an interest in the project and to investigate funding opportunities.

**Resolved** to give consent to Cllr Gary Jones to use a drone on all Council land which will assist in external filming in the community.

#### Tumble Park

The CDO reported that there had been some difficulty in arranging a meeting with Tumble schools to develop additional consultation with the children in the community however a meeting has been agreed for 6<sup>th</sup> November with the headteacher. A second stage application will be submitted to Welsh Government for the improvement to the play area by mid-December.

#### Christmas Festivities

It was resolved to approve the following actions:

- The Xmas fete has been agreed for the 1<sup>st</sup> December at Tumble Hall.
- It was agreed to consider the purchase of Christmas trees from Troserch woods.
- It was noted that marquees were used for the celebration of the Christmas switch-on last year which were loaned to the Council from the previous CDO. It was agreed to request the CDO to approach the previous CDO to see if the Council are able to purchase the marquees or alternatively to purchase new marquees in readiness for the Christmas festivities. There was also a discussion regarding the option to acquire a public address system. The CDO was requested to investigate grant assistance for this purchase.

#### Community Newsletter

The CDO provided additional information on the proposal for a community newsletter. It was **resolved** to approve the proposal to establish a regular community newsletter and agreed that members will feed information to the CDO for inclusion in the publication.

#### Tumble Hall Events

An update was provided on the proposed stage school which is being established at Tumble Hall. It is proposed to stage a show will be held at Tumble Hall on the 6<sup>th</sup>/7<sup>th</sup> April.

- An additional meals on wheels service was provided last Sunday.
- A skip has been organised for the Maesgwern estate to alleviate fly tipping problems in this area.
- Funding has been secured to widen the pavement to the highway on the side of the Cross Hands Hotel.
