Dywedodd y SCC bod RMS wedi gwrthod darparu peiriant cerdyn (at ddefnydd gwneud gweithrediadau ariannol) ar gyfer y Cyngor a Neuadd y Tymbl.

Minute no. 191 – Remembrance Day

It was noted that there was an issue with the timing of the service this year. Unfortunately, the service at Tumble had started late which meant that the service at Cross Hands had started when people were arriving. It was **resolved** that there is a need for members to bring this problem to the attention of the respective organisers in readiness for future events.

Minute no. 192 – Adopt a Kiosk

It was reported that there is a need to provide an earthing facility for the kiosk by way of Western Power providing a PME supply. **Resolved** to instruct the Clerk to contact Western Power to establish whether this facility is available at the location of the kiosks.

Minute no. 193 – Cross Hands Park Sign

Members raised a concern regarding the poor condition of the above sign. **Resolved to** follow this matter up with the caretakers to see if the sign can be renovated.

Minute no. 194 – PACT/Police Report

There was no report available from the Police regarding crimes in the area.

Minute no. 195 – Finance Reports

The RFO provided an overview on the previously circulated reports including the following:

There was a general discussion regarding the content of the reports and the following additional information was considered:

- It was reported that the bank mandate has now been resolved.
- The RFO is still awaiting the printed cheques to be delivered from the bank for use in the month end cheque run.
- There is a need for a review of the allocation of funds into the various budget headings. The RFO will liaise with the Clerk in resolving this matter.
- There have been issues raised by HMRC with regard to payroll accounts resulting in an over-payment. This has been due to HMRC assuming that there were 2 sets of payroll activity on-going during the period.
- The RFO outlined that a reporter from Llanelli On-Line has agreed to publish information regarding the activities of the Council. It was agreed that some members of the Council are concerned that Llanelli On-line has a political bias that any press releases from the Council will be copied to Y Cneifiwr as well as Llanelli On-line.
- A request was made for the RFO to provide an update of the way that the singles night is being organised.

Tumble Park

It was noted that the children of the 2 Tumble schools have provided drawings of their preferences for the park development. This will be used as evidence for the next stage of the RCDF grant claim for the park.

Christmas Tree

The Clerk reported that the Council has received Christmas trees from Troserch woods and will be erected in time for the switch on. The Clerk reported that it had not been possible to purchase alternative coloured lights in readiness for the switch on at a reasonable price.

CETMA event

The RFO encouraged all Councillors to pass on information on the proposed CETMA event to local residents and to attend the event themselves if possible.

Stage School

A report was provided on the uptake of places at the new stage school. It was noted that there is still room available for the 9-14 age group to fill some of the remaining places at the stage school. **Resolved to** agree to the promotion of the school by providing tee-shirts for the participants.

- He is investigating a land acquisition issue with regard to Ravelston Court.
- Grugos woods – It has been discovered that plastic and asbestos material has been detected in part of the development already completed at this site.
- New Bus Stop - The housing department is proposing to provide a new bus stop at Maesderi with the old bus stop demolished and a new fence erected. There was a query as to the extent of consultation that has taken place with the tenant more particularly as to whether the old shelter needs to be demolished or retained for use by the tenant. Cllr Dole agreed to follow up on this matter.

Minute no. 202 – Staff Hall Meeting

The Council received the notes of the recent staff meeting. It was **resolved** to accept the following recommendations:

Minute no. 204 - Fly Tipping - Tumble Car Park

Members discussed the problems currently occurring at the car park with regard to fly-tipping. The Clerk provided a report on a recent meeting with the County Council Enforcement Officer with regard to the policies of the Council. The following matters were agreed:

- There will be further signs provided to the area informing members of the public of the policies of the County Council with regard to the use of the site.
- The County Council will seek to empty bins on a more regular basis.
- The Council will consider prosecutions in the near future based upon the CCTV evidence
- The Clerk will act as responsible officer with regard to any prosecutions requiring evidence from the Council.
- The Council needs to consider its policy with regard to CCTV and compliance with current policies.

Minute no. 205 – Cross Hands Bowls Pavilion and Changing rooms

The Clerk provided an update on the negotiations with the County Council with regard to the Asset Transfer of the above properties, more specifically the fact that the offer from the County had increased to £35,000 payable up front to the Council. It was noted that the Council's workmen are capable of completing improvement works including the provision of a masonry wall to replace the existing timber structure should this be appropriate.

It was **resolved** to accept the offer from the County Council and proceed with work to weatherproof the structures.

Further **resolved** to arrange a site meeting with Councillors and the caretakers to discuss proposals for future use of the changing rooms. It was agreed that the changing rooms need to be opened for viewing by the following people - Councillors N Holman, K Thomas, EW James, M Jones and G Jones.
