3.d The person presiding over the meeting must give members of the public in attendance a reasonable opportunity to make representations about any business to be discussed at the meeting, unless doing so is likely to prejudice the effective conduct of the meeting. This does not mean that members of the public can take part in debate, but they must be given a reasonable opportunity to make representations about business to be discussed.

3.e The period of time designated for public participation at a meeting in accordance with standing order 3(d) shall not exceed ten minutes unless directed otherwise by the chair of the meeting.

3.f Subject to standing order 3(e), a member of the public shall not speak for more than two minutes.

3.g In accordance with standing order 3(d), a question shall not require a response at the meeting nor start a debate on the question. The chair of the meeting may direct that a written or oral response be given.

3.h A person shall raise their hand when requesting to speak.

3.i A person who speaks at a meeting shall direct their comments to the chair of the meeting.

3.j Only one person is permitted to speak at a time. If more than one person wants to speak, the chair of the meeting shall direct the order of speaking.

3.k Photographing, recording, broadcasting or transmitting the proceedings of a meeting by any means is not permitted without the Council's consent.
