The Chief Officer stated that Carmarthenshire County Council work out the costings for polling cards and the cost will be around £6,000.

   13.8% turnout.

The Chair asked the Council whether the members present wish to purchase polling cards for the upcoming by-election.

PO stated that he would rather take the money off the next budget and doesn't think that LICC need to purchase polling cards.
