The Chief Officer informed the Council that there wasn’t a meeting this month with the police.

Minute No. 146 – The Chief Officers’ report.

The Chief Officer reported on the following:

The Chief Officer is waiting for a response from the Welsh Government regarding the loan application.
- **Pavilion redevelopment**
The Chief Officer has had many meetings with CFF who have informed her that they are considering moving the application to January’s panel. The Chief Officer has informed the Clubs of the present position.
- **James Williams event**
The James Williams event was very successful and everyone who attended the event thoroughly enjoyed. Many of our Cinio & Chlonc members attended the event and it was very encouraging to see people coming out for the evening.
- **Events.**
The Chief Officer informed the Council that KB has organised many events for the month of December and thanked her for her hard work.

All of the Christmas trees will be switched on tomorrow. The Christmas light switch on at Cross Hands will be followed by a Christmas service at St Anns Church.

- **Cinio & Chlone**

The Christmas dinner will be held on the 5th December with over 100 members booked in so far.

- **Community Christmas Concert**

The Community Christmas concert will be held in Tumble Hall on the 7th December which has been advertised on social media.

- **Polar Express Film showing**

The Polar Express Film will be shown at Tumble Hall on the 17th December this has been advertised on social media.

- **Christmas breakfast packs**

For the Christmas period residents will be able to order breakfast packs ready for collection on the 19th December. Residents can order these packs through a link that has been advertised on social media.

- **Maintenance**

The maintenance team have been busy preparing the memorial gardens ready for Remembrance Sunday. They have also been installing the Christmas trees and lights in preparation for LICC's Christmas light switch on. The Chief Officer thanked the maintenance team for all their hard work.

The Chair thanked all members of staff for their hard work and stated that she felt that the breakfast packs are a very good idea and will hopefully help many families during the Christmas period.

Minute No. 147 – To present cheques for financial assistance donations agreed in October's meeting.

The Chair stated that it was a real pleasure to welcome two representatives from the local community to LICC's meeting this evening. The Chair also stated that each of these groups undertake outstanding work, providing vital support and assistance to residents of the ward and wider area. The Chair stated that it

is both an honour and a privilege to present a grant of £500 to each group to further support their exceptional contribution to the community.

The Chair presented a £500 donation to Merched Y Wawr and Cyfle I Bawb and thanked both of their representatives.

Minute No. 148 – To discuss requests for Financial Assistance.

The Chief Officer has received requests for Financial Assistance from:

- Carmarthenshire County Council's Toy Box Appeal

The Chief Officer informed the Council that if they wished to make a donation with regards to the above requests then they would need to make a virement to increase the Financial Assistance Donations budget to allow them to do so.

The Chief Officer advised the Council that it was possible to take £500 from the Members Financial Loss Payment and £500 from the Members Care/PA allowance. This would then allow the Council to increase the Financial Assistance Donations budget up to £5,000.

NT proposed that the RFO does a virement on the budget and move £500 from 'Members Financial Loss Payment' and £500 from 'Members Care/PA allowance' and allocate £1000 to the 'Financial Assistance Donations' budget. PO seconded the proposal. All members present in favour.

Resolved to move £500 from 'Members Financial Loss Payment' and £500 from 'Members Care/PA allowance' and allocate £1000 to the 'Financial Assistance Donations' budget.

The Chief Officer informed the Council that she has received all of the required paperwork from Tumble Lindy Hop and Jive and that they are requesting a donation of £500.

NT proposed that LICC donate £500 to Tumble Lindy Hop Jive. EGE seconded the proposal. All members present in favour.

Resolved that LICC donate £500 to Tumble Lindy Hop Jive.

The Chief Officer informed the Council that she has received a request from CCC for their Toy Box appeal. The Chief Officer also informed the Council that a donation can be made by money or toys.

The Councillors present discussed whether or not to make a donation to the Toy Box appeal and whether to donate money or toys.

SH proposed that LICC purchase £300 worth of toys and donate the toys to Carmarthen County Council's Toy Box Appeal. JG seconded the proposal. LD, JA and PO abstained from voting. All other members present in favour.

Resolved that the Council donate £300 worth of toys to Carmarthen County Council's Toy Box Appeal.
